Businessman S. Tabenken is dead at 74

Samuel Tabenken, president and chairman of the board of H. Tabenken and Co., Inc., for 33 years, died Monday at the age of 74 at Eastern Maine Medical Center.

Tabenken was born in Portland and attended Portland University before starting out on his business career. He founded H. Tabenken and Co., Inc., distributors of wine, beer and beverages in Bangor, and also founded Tablease, Inc., an automotive equipment leasing firm in Bangor.

In 1978, Tabenken received an honorary doctoral degree in businessadministration from Nathaniel Hawthorne College in Antrim, N.H. He was recognized by "Who's Who in the East," "Who's Who in Business and Finance," and the "Dictionary of International Biographies."

He was a patron of the Bangor Symphony Orchestra, the Opera New England of Northern Maine, and other arts and civic groups. He was active in trade organizations, including the Maine Wine and Beer Wholesalers Association, Maine Advisory Board of U.S. Brewers Foundation, and Wine Marketing International.

In 1964, Tabenken was appointed to the Advisory Council of Small Business Administration for the State of Maine. He was to be honored on Tuesday, June 17, by the Maine Beer and Wine Wholesalers Convention in Kennebunkport.

Mr. Tabenken was a member of the Masonic Civic Lodge of Manhattan, N.Y., the Scottish Rites Bodies of New York City, a 32nd degree Mason and member of Anah Temple Shrine of Bangor. Mr. Tabenken was listed in "Who's Who in the East" since 1972 and "Who's Who in Business and Finance" since 1975 and listed in the "Dictionary of International Biographies" since 1975. Mr. Tabenken was the recipient of an Honorary Doctoral Degree in Business Administration in 1978 from Nathaniel Hawthorne College of Antrim, N.H. Mr. Tabenken was to be honored June 17 by the Maine Beer and Wine Wholesalers Convention Banquet for his long years of service and legislative guidance to the industry at the Colony Hotel in Kennebunkport. He was a member of the Congregation Beth Israel. He is survived by his wife, Sally (Saklad) Tabenken, a son, James, both of Bangar; a daughter, Beth, of New York City; one brother, Gerald Tabenken, of Bangor; two sisters, Mrs. Ann Weisman and Miss Suny Tabenken, both of New York City; a sister-inlaw, Mrs. Morris Tabenken, and her son, Harry Tabenken, both of Bangar; a brother-in-law.
